Na Ka Meinga hei Ture e te Runanga Nui o Niu Tireni e noho huihui ana i roto i te Paremete i runga ano hoki i tona mana, ara:—

- Ko te Ingoa Poto o tenei Ture ko "Te Ture Whakakore i te Whiu ki te Whare Herehere mo te Nama, 1893." Ka timata tona mana a te tahi o nga ra o Oketopa o tenei tau, 1893.
- Ahakoa tetahi mea e mau ana i roto i "Te Ture Whakakore i te Whiu ki te Whareherehere mo te Nama, 1874," e kore tetahi tangata i muri iho i te timatanga o tenei Ture e hereherea mo tetahi moni kihai i neke ake i te kotahi rau pauna tona nui, a i tika kia utua i raro i tetahi whakataunga tetahi ota ranei a tetahi Kooti whai mana.

Kahore tetahi mea e mau ana i konei e whakarereke i ona tikanga—

- Ara e pa e whakakore ranei i tetahi take tetahi mea ranei i whakakorea e taua Ture i runga i nga tikanga whakahaere o te tekiona toru o taua Ture.

A Bill Intituled

AN ACT further to limit Imprisonment for Debt.Title.

Be It Enacted by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

- The Short Title of this Act is "The Imprisonment for Debt Short Title. Abolition Act, 1893." It shall come into force on the first day of October in the now current year.
- Notwithstanding anything contained in "The Imprisonment Imprisonment for less than £100 totally abolished for Debt Abolition Act, 1874," no person, after the commencement 10 of this Act, shall be imprisoned in respect of any sum of money not exceeding *one hundred* pounds in amount, and due under any judgment or order of any Court of competent jurisdiction.

Nothing herein contained shall be construed—saving.

- To affect or annul any matter or thing excepted by the said 15 Act from the operation of section three thereof; or
- To take away, alter, or limit the jurisdiction which any Court, Judge, or Magistrate now possesses under the said Act or any other Act for the arrest of any persons believed to be about to quit the colony.
